Each of the undersigned certifies and warrants that he is the lawful owner of the interest set out below in all oil (defined as crude oil and condensate) and/or in the proceeds derived from the sale of all gas (defined as natural gas and casinghead gas) produced from the Steinfeldt Unit, located in Logan County, State of Oklahoma, and more particularly described as:

Logan County, Oklahoma**

Effective next distribution, and until further written notice, you and your assignee, nominee or vendee are authorized and directed to receive the proceeds of oil and/or gas and pay the owners for their respective interests, stated and guaranteed as follows:

See Exhibit "A" attached hereto and made a part hereof

Payment for said products taken from the above described land during any calendar month shall be made on or before the 28th day of the month following receipt of the proceeds. It is agreed that if, at any settlement date, the amount payable to any party hereunder shall be less than Twenty-five Dollars (\$25.00), you may defer payments, without interest, and make such payments as soon as Twenty-five Dollars (\$25.00) has accumulated; provided that, regardless of the total, payment of the accumulated amounts shall be made in December of each year.

All payments attributable to the interest of the undersigned in production from the well shall be made on the basis of the contract price received by you from the sale of such production, (or, if there be no contract, the price actually received by you in respect to such production), and upon the basis of the volume computations made by the purchasers of such production.

In the event of any adverse claim or dispute arising at any time concerning title as to any interest or interests covered hereby, you are authorized to withhold, to the extent which you deem necessary for your protection, the proceeds accruing from purchases hereunder, without interest and without liability, until indemnity satisfactory to you has been furnished or until such dispute or claim has been settled to your satisfaction. Each undersigned party, as to the interest of such party hereunder, respectively agrees, in the event suit is filed in any court affecting title to said oil and/or gas or proceeds thereof either before or after severance, to indemnify and save you harmless against any and all liability for loss, cost, damage and expense which you may suffer or incur on account of receiving and paying said party the proceeds derived from the sale of said oil and/or gas.
