Dear Mr. Oliver:

I have your note of February 19th in regard to the payment of royalties to you and your brother.

On September 18th, 1975, I sent all of the recorded copies from each of the Counties in Oklahoma where mineral interests were owned, together with the Tax Clearance from the State of Oklahoma, which I had recorded in the various Counties, to your attorney, Mr. Charles W. Edwards. I enclose a copy of this letter and call your attention to paragraph two.

Since I do not have these copies, you will have to contact Mr. Edwards and have him do, if he has not already done so, what I suggested in my letter. I find it rather difficult to be of assistance to you since I have fulfilled all that I could do from this end.

However, in the unlikely event, that Mr. Edwards has not performed the request which I set forth in this letter, we could go back to the District Court here in Oklahoma and get certified copies of the Decrees. However, I do not have, and will have very great difficulty in obtaining duplicates from the Oklahoma Tax Commission for the clearance of the various Counties. I would suggest that you contact your attorney immediately in regard to this matter and call to his attention this letter.

I think that this will probably cure your ills and I certainly hope so. Division Orders should have been issued a long time ago by the Companies. Remember that you have to give the oil companies the description of the property and the farm or lease number which appears on the check. For instance
